BUHL HIGHWAY DISTRICT NO SPRAY ZONE APPLICATION

INFORMATION TO APPLICANT:

The Buhl Highway District No Spray Policy allows persons living in the District to request a No Spray Zone along County road rights-of-way adjacent to their properties provided they understand and comply with the following criteria:

- It is understood and agreed that Idaho Code Title 22, Chapter 24, imposes the duty and
 responsibility for controlling noxious weeds on private lands upon the person who owns or
 controls the land, and Idaho Code Title 22, Chapter 24, imposes the duty and responsibility for
 controlling noxious weeds on the lands and rights-of-way of a highway district upon the
 administering district.
- 2. This No Spray Zone Application form must be signed and returned to the District by March 15th before the spray year. The No Spray area is granted on a year-by-year basis.
- 3. All relevant information and attachments must be supplied. The District Clerk of the Highway District shall determine the completeness of the application's information, which shall include determining the required signage and fees. No application shall be considered filed by the Highway District unless the application form is completed, and the property owner has acquired the required signage.
- 4. All applications can be submitted to the Highway District at the administrative office located at 1500 West Main Street, Buhl, ID., 83316. Applications can also be submitted via email at clerk@buhlhd.com; any questions can be directed to the District Clerk (208) 543-4298.
- 5. If the applicant fails to comply with this policy or the rules established by the Board of Highway District Commissioners in regard to the No Spray Zone, said property adjoining the roadway shall be sprayed or mowed by the Buhl Highway District and the applicant shall no longer be entitled to qualify for No Spray Zone status of that calendar year.
- 6. The Buhl Highway District requires the signage below to comply with the No Spray Zone requirements. The required signage may be purchased from the Highway District for \$68.00.
